


RESOLUTION 32

WHEREAS, Section 1.07(6) of the Municipal Code of the Town of Delavan requires that the Town Board prescribe the requirements of disclosure regarding said statement of economic interests.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Delavan, Walworth County, Wisconsin, does hereby establish that all candidates for elected office in the Town of Delavan and all elected officials in the Town of Delavan provide to the Town Clerk within thirty (30) days after having received a copy of the attached questionnaire, which is incorporated herein by reference, said questionnaire in completed form.
