

RESOLUTION NO. 3.2008  
TOWN OF DELAVAN, COUNTY OF  
WALWORTH, STATE OF WISCONSIN  
Date: June 17, 2008

WHEREAS, the Town Board of the Town of Delavan, Walworth County, Wisconsin, has, by ordinance, mandated that the Town Board adopt a fee schedule for the use of the Town of Delavan Community Park, boat launch fees and related matters; and

WHEREAS, the Town Board of the Town of Delavan is desirous of adopting a uniform schedule for the use of the Town of Delavan Community Park facilities.

NOW THEREFORE, BE IT RESOLVED by the Town Board of the Town of Delavan that the fee schedule set forth herein is hereby enacted pursuant to the provisions of the Town of Delavan Municipal Code, as follows:
