

RESOLUTION OF THE TOWN BOARD
OF THE TOWN OF DELAVAN,
WALWORTH COUNTY, WISCONSIN

WHEREAS, it is deemed expedient that the Municipal Code of the Town of Delavan be brought up to date; and

WHEREAS, Ordinances adopted through Ordinance number 126 and changes necessitated by changes in State Law have now been incorporated in a proposed new Municipal Code; and

WHEREAS, Sec. 66.035, Wis. Stats., requires that said proposed Code be on file and open to public inspection at the office of the Clerk for the Town of Delavan for at least two weeks prior to its adoption and permanently on file thereafter.

NOW, THEREFORE, BE IT RESOLVED that:

1. The proposed Municipal Code of the Town of Delavan, in book or pamphlet form, be placed on file, open to public inspection, at the office of the Clerk for the Town of Delavan.

2. Notice by publication be given in The Delavan Enterprise that the proposed Municipal Code will be on file at the Town of Delavan Clerk's office for public inspection for not less than two weeks prior to the adoption of the new Code and that the Town Board will consider the adopting of said proposed Municipal Code and hold a Public Hearing thereon at the regular Town Board Meeting to be held in the Delavan Town Hall on Tuesday, November 19, 1985 at 7:00 p.m. Town Hall Road, Delavan, Wisconsin.
